### 1 – PRODUCT IDENTIFICATION AND COMPOSITION

**NAME:** Orthodontic Composite Bracket  
**COMPOSITION:** Polycarbonate

**GENERAL DESCRIPTION:**

**INDICATION:** Orthodontic treatment.
